flames and apply the agent as gently as possible. Overall, give preference to using medium to wide spray patterns rather than solid streams. Use only non-sparking tools. Fire fight from a protected location or maximum possible distance. Use water spray/fog for cooling fire exposed containers. Avoid unnecessary run-off of extinguishing media which may cause pollution.

SECTION 6: Accidental Release Measures

Personal Precautions, Protective Equipment, and Emergency Procedures:
